**Guidelines and Criteria for nominating and electing Trumansburg Area's Business/Business Person of the Year**

1. Candidates must have been in business in the Trumansburg area (includes Jacksonville, Interlaken, Hector, and Ovid) area for at least 1 year and be a chamber member in good standing.
2. The business or business person nominated should demonstrate exemplary behavior toward other businesses and peers, and contribute in positive ways to the community.
3. A final slate of candidates for the business/person person of the year shall be selected by the nominating committee, which consists of at least three (3) active members of the TACC.
4. The candidates will be voted on by the TACC Board of Directors using paper ballot. The candidate must have a two thirds (2/3) majority of votes to receive the award.
5. The award will be presented at the TACC annual dinner in November.
